*Summary of Results*

# Methodology

- ▶ Hybrid telephone/email-to-web survey of likely March 2020 voters in the Alameda Unified School District
- ▶ Survey conducted July 24-30, 2019 and offered in both English and Chinese
- ▶ 608 interviews; overall margin of error  $\pm 4.0$  percentage points
- ▶ A split-sample methodology was used to test two potential parcel tax amounts:
  - Sample A: \$0.28/sq ft; \$11,000,000 estimated annual revenue (n=304; margin of error  $\pm 5.6$  % pts)
  - Sample B: \$0.18/sq ft; \$7,600,000 estimated annual revenue (n=304; margin of error  $\pm 5.6$  % pts)

*Please note that due to rounding, some percentages may not add up to exactly 100%.*

# Key Findings

---

- ▶ Alameda voters believe Alameda Unified School District is doing a good job and many agree quality schools are worth increased taxes.
- ▶ Few feel that the District pays teachers and staff adequate salaries and benefits.
- ▶ Support today for a parcel tax measure for teacher and staff salaries and benefits falls below the two-thirds threshold required to pass, with no measurable difference between the two tax amounts tested.
- ▶ Additional information about what the measure would increase support to near the two-thirds threshold, including helping to sustain strong academic programs, attracting, retaining, and supporting teachers and employees, and making salaries and benefits competitive with local districts.
- ▶ There is some evidence that opposition messaging could have an impact on support.








Q5 Do you think things in Alameda are generally going in the right direction or do you feel things have gotten pretty seriously off on the wrong track?

*A majority of voters rate the job the Alameda Unified School District is doing positively, and they are particularly enthusiastic about the teachers. Two-thirds rate the District negatively on adequate pay and benefits for teachers and staff.*




Q6-11 Regardless of whether or not you have children currently in school please rate each of the following areas relating to the Alameda Unified School District:

Current AUSD Parents ONLY (29%; n=169)



Nearly a majority of voters, and six-in-ten parents, believe Alameda USD teachers are among the lowest paid in the County.


Agree/Disagree: "Teachers in Alameda Unified School District are among the lowest paid in the County."

# Tax Sentiment


*Many agree that quality schools are important even if it means raising taxes.*

Q12. Would you say that schools in the Alameda Unified School District have a great need for more money, some need for more money, little need for more money, or no real need for more money?




# Parcel Tax Measure

# Parcel Tax: Initial Vote

Support today for a parcel tax measure falls below the two-thirds threshold required to pass and there is no difference in voter receptivity to the higher or lower amounts tested.

To maintain high-quality Alameda schools by attracting and retaining excellent Alameda Unified teachers and employees, making teachers' and employees' salaries and benefits competitive with local Districts, sustaining strong academic programs in reading, writing, math, arts, and sciences, shall an Alameda Unified School District measure to levy [SAMPLE A: \$0.28 /SAMPLE B: \$0.18] per square foot of building area per year, until ended by voters, with a \$7,999 cap per parcel, be adopted, raising [SAMPLE A: \$11,000,000 /SAMPLE B: \$7,600,000] annually with senior exemptions, audits, oversight, and all funds staying local?





- Failed Measure



*Top voter priorities include helping to sustain strong academic programs and attracting and retaining teachers and employees.*



# Additional Information

*Additional information resonates with voters, particularly about great teachers and good schools keeping the community strong, and the need to increase salaries to keep good teachers here and allow them to focus on educating.*

Great teachers and good schools are a part of what makes Alameda a great place to live. By keeping our local schools strong, we keep the community strong.



Alameda schools lose nearly 20% of their teachers and staff to other school districts each year mostly because of low pay. We need this measure to keep qualified and experienced teachers in Alameda classrooms and teaching local kids.



Many Alameda teachers and staff have had to take on second and even third jobs in order to support themselves and their families. This measure will increase teacher and employee salaries so that they can focus on the important job of educating and supporting our kids.



The revenue from this measure can only be used to pay teachers and other educational employees and cannot be used for any other purpose.





This measure will help the District to attract and retain the best teachers and staff and help them afford to live in the community where they work.




Alameda Unified School District teachers are among the lowest paid in the County. This measure will ensure our teachers are getting the pay they deserve.



This measure is structured to ensure that large commercial property owners pay their fair share to support our schools.



Annual audits and independent citizen oversight will ensure that all funds are spent right here in Alameda schools and cannot be taken away by the State.








This measure will help the District retain the experienced Alameda teachers and staff that are the backbones of our schools and also serve as mentors and resources to the next generation of educators.



Alameda's schools are doing a great job educating our children, thanks largely to our excellent teachers. This measure helps the District continue to provide high-quality schools and a top-notch education by attracting and retaining the best qualified teachers.



Recently, teachers in similar communities have gone on strike to demand higher compensation. This measure will increase teacher salaries so that we can avoid a strike, which would divide our community and hurt the quality of education for local students.






# Sunset Provision

Average of both ballot questions





# Conclusions

---

- ▶ A parcel tax measure to support competitive pay and benefits for AUSD teachers and staff is potentially feasible for the March 2020 ballot.
- ▶ Voters are most interested in a measure to improve pay when it is directly connected to the District's ability to retain excellent teachers and staff in local schools and continue to provide quality educational and support programs.
- ▶ The area's high cost of living is a double-edged sword—while voters are aware that the District's teachers and staff may be inadequately compensated, many are likely facing the same hardship themselves and are reticent to increase their own taxes.
- ▶ The no-sunset provision may be a vulnerability; including a sunset may be important.
- ▶ A robust, privately funded communications effort is strongly recommended to ensure voters understand the need for and benefits of a measure.
