ADOPT A REVISED CATEGORICAL FLEXIBILITY FOR FISCAL YEAR 2009/10

WHEREAS, the students in the Alameda Unified School District deserve the highest quality education; and

WHEREAS, the Legislature and governor have continued to impose significant education cuts since September 2008, resulting in significant reduction of essential programs and services to students that are integral to their success, and

WHEREAS, these statewide budget reductions will result in serious cuts in the Alameda Unified School District necessitating \$17 million in strategic cuts to be implemented over the next three school years; and

WHEREAS, SBX3 4 provided limited fiscal flexibility through the 2012-2013 year to allow school districts to utilize funding received from the state budget act for "Tier 3" categorical programs for any educational purpose; and

WHEREAS, the governing board of the Alameda Unified School District took testimony at a regularly scheduled public hearing from the public, including parents, community members, and representatives from all school personnel including teachers, administrators and classified employees; and

WHEREAS, following the public testimony, the board discussed the flexibility provision, how to prioritize the use of limited resources, and the effect on the specific programs offered by the school district; and

WHEREAS, any transfer of funds will be used to ensure that the district's overall goals for student learning will be at the forefront of the use of this flexibility; and

NOW, THEREFORE, BE IT RESOLVED that, following a public hearing in which input was provided by a broad array of stakeholders, the Alameda Unified School District will utilize the flexibility provided through SBX3 4 during the state's fiscal crisis to transfer funds in Tier 3 categorical programs for any educational purpose.
